- In case of rain, the activities ARBRE-EN-CIEL VILLAGE and ARBRASKA RAWDON Inc. continue. Therefore, there will be no refund or compensation. In case of an electrical storm, park management reserves the right to interrupt the activities for safety reasons. Again, no refund or compensation will be given.
- It is strongly advised before beginning the activities that you attach long hair, wear sport and comfortable clothing. You are in a forest environment. ARBRE-EN-CIEL VILLAGE and ARBRASKA RAWDON Inc. are not responsible in the case of marks or tears to clothing and shoes sustained in the activities.

**ARBRE-EN-CIEL VILLAGE REGULATIONS**

- It is forbidden to be on drugs or alcohol in the ARBRE-EN-CIEL VILLAGE. Drugs are totally forbidden all the time on the site.
- It is formally forbidden to smoke within 9 meters of the ARBRE-EN-CIEL VILLAGE, the chalet and the forest.
- Adults must supervise their children at all times and make sure they follow all the rules and regulations in effect.
- Respect your designated return time to the chalet for the good of everyone. Wristband must be wear at the risk at all time while participating in the activities.
- Additional costs will be charged if the set time limit is not respected.
- It is forbidden to eat or drink outside the designated areas.
- Participants must respect the other participants and wait their turn if there is a lineup.
- It is forbidden to walk outside of the designated areas. Slides are to go down only. 5 people maximum per treehouse.
- It is forbidden to run within the ARBRE-EN-CIEL VILLAGE and anywhere in the forest or play games like the 'tag'.
- It is obligatory to participate at the security briefing before attending the activities.
